The undersigned, for the purpose of forming a professional corporation in accordance with Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I - Name and Address

The name of the Corporation shall be PAUL S. KIMSEY, P.A. The address of the principal office of this corporation shall be 1211 W. Fletcher Ave., Tampa, Florida 36612, and the mailing address of the corporation shall be the same.

Article II - Nature of Business

The name and address of the person signing these Articles is Paul S. Kimsey, 1211 W. Fletcher Ave., Tampa, Florida 33612.


Article V - Initial Registered Agent
