**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 607.1006, Florida Statutes, as made applicable through Section 621.13, Florida Statutes, Kimsey Law Group, P.A., a Florida professional service corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:
