The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is Bay Bayou Traveler, Inc. The principal place of business of this Corporation shall be 17342 Gunn Hwy., Odessa, Florida, 33556, or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue Twenty-Two Thousand (22,000) shares of common stock, no par value, Twenty Thousand (20,000) shares of which shall be non-voting stock and Two Thousand (2,000) shares of which shall be voting stock.
