I never received a notice informing me that my corporation would be dissolved if a report was not filed. Freedan Wako was the president of the company up until his death on June 28, 1998. He was diagnosed with a brain tumor in March of 1998. We also let go of our attorney in October of 1998 because of financial difficulties.
