

To whom it may concern:

I never received a notice informing me that my corporation would be dissolved if a report was not filed. Freedan Wakoa was the president of the company up until his death on June 28, 1998. He was diagnosed with a brain tumor in March of 1998. We also let go of our attorney in October of 1998 because of financial difficulties. However, the mailing address has always been the same, and as I noted, I never received any report notifying me of an impending dissolution of my company.

Because of the aforementioned reasons, I request that you waive the \$600 reinstatement fee. My company has just now begun to do business, and we would not be able to pay this fee. I spoke to one of your representatives on the phone and was told to send you this letter of explanation along with a check of \$150. Enclosed please find the check.
