ARTICLES OF INCORPORATION OF EAD CONSTRUCTION MANAGEMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address. The name of the Corporation is: EAD Construction Management, Inc. The principal office, if known, or the mailing address of the Corporation is: 12950 SW 34th Place, Davie, Florida 33330.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
