ARTICLES OF INCORPORATION FAMILY STAR, INC.

Pursuant to the Florida Business Corporation Act, the undersigned incorporator, for the purpose of forming a corporation, hereby adopts the following Articles of Incorporation that provide:

- 1. The name of the corporation shall be Family Star, Inc. (the "Corporation").
