Please find enclosed the signed 2001 Uniform Business Report (UBR) for the above-referenced corporation, along with a check in the amount of \$150 payable to Department of State.

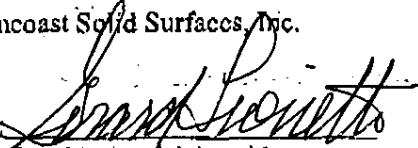
