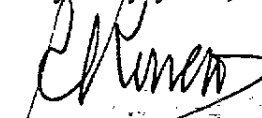

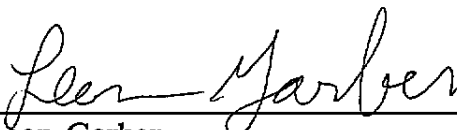
VI. DIRECTORS

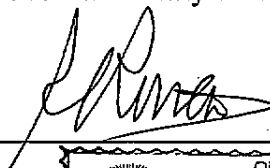
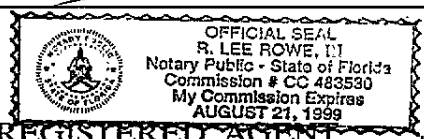
