ARTICLES OF INCORPORATION

FIRST: I, SAMIRA RAZZAQ whose post office address is 11173 POINT SLYVAN CIR, # C ORLANDO, FL 32805 Being at least eighteen (18) years of age, hereby form a corporation under and by virtue of the General Laws of the State of Florida.
