ARTICLES OF INCORPORATION

OF

The undersigned natural persons, competent to contract under the Last of Chapter of Florida, acting as subscribers of these Articles, under the provisions of Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

- 1. NAME: The name of the corporation is:
 MILJO SALES CORP.
- 2. NATURE OF BUSINESS, PURPOSES AND POWERS: The general nature of the business or businesses to be transacted by this corporation and purposes and powers of this corporation are as follows:
