ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation are natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I
NAME

The name of this Corporation shall be PRIMARY CARE CENTER, P.A. The Corporation's principal address and the registered office address are the same.

ARTICLE II
DURATION

The Corporation shall have a perpetual existence.

ARTICLE III
PURPOSE

The purpose of this professional corporation is for the sole and specific purpose of rendering professional services to the public for profit in the field of medicine and which has as its shareholders only individuals, professional corporations or professional limited liability companies who themselves are duly licensed or otherwise legally authorized within this state to render the same professional services as the Corporation.

ARTICLE IV
CAPITAL STOCK

The maximum number of shares which this Corporation is

authorized to have outstanding at any time is 5,000 shares of common stock having a par value of \$1.00 per share.

Authorized capital stock may be paid for in cash, services, or property.

ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Corporation shall be 1042 Jenks Avenue, Panama City, Florida 32401, and the initial registered agent of this Corporation at such office shall be **Richard Albritton, Jr., Attorney-At-Law**, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI
INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of one (1) member. The number of Directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of Directors be less than one (1) nor more than ten (10).
