## ARTICLE I CORPORATE NAME

The name of this corporation is **THE ENGET INSTITUTE SCHOOL OF MASSAGE THERAPY, INC.** 

## ARTICLE II INITIAL PRINCIPAL PLACE OF BUSINESS

The corporation's initial principal place of business shall be 805 E. Oak Street, Suite 1, Kissimmee, Florida 34744.

## ARTICLE III NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to operate as a school, as defined in Section 246.203(1), Florida Statutes.
