

#### ARTICLES OF INCORPORATION

OF

#### MOSER ENTERTAINMENT, INC.

#### ARTICLE 1 - Name

The name of the corporation is Moser Entertainment, Inc.

#### ARTICLE 2 - Address

The street address of the initial principal office of the corporation is 2318-B Winterwoods Blvd., Winter Park, FL 32792. The mailing address of the corporation is the same.

#### **ARTICLE 3 - Shares**

This corporation is authorized to issue 1,000 shares of \$1.00 par value common shares. All issued shares must be represented by certificates.

#### **ARTICLE 4 - Preemptive Rights**

Each shareholder, upon the sale for money of any new shares of this corporation of the same class or series as that which the shareholder already holds, shall have the right to purchase a pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
