### ARTICLES OF INCORPORATION

ARTICLE I:

NAME

The name of this Corporation shall be: ROYAL COMMUNITY MENTAL HEALTH CENTER, INC.

ARTICLE II:

NATURE OF BUSINESS

This Corporation may engage any activity or business permitted under the las of the United States of America and the laws of the State of Florida.
