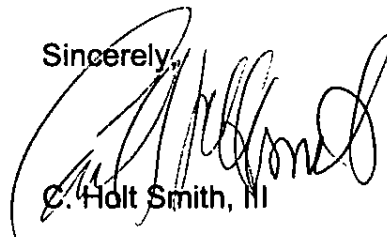

THIRD: Dissolution was authorized on December 1, 2008 by unanimous vote of the shareholders of the corporation.

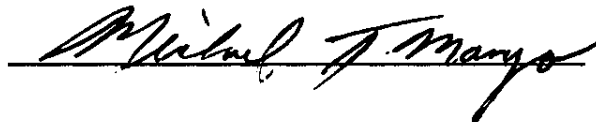
FOURTH: No debt of the corporation remains unpaid and there are no creditors.

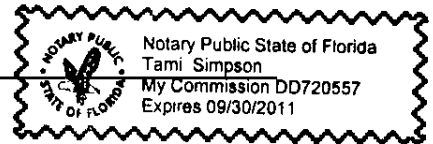
