The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is STANDARD TECHNOLOGY INTERNATIONAL, INC. The corporation's initial principal place of business shall be 2665 South Bayshore Drive, Suite 201, Coconut, Florida 33133.

ARTICLE II

Duration and Existence

This corporation shall exist perpetually. The existence of the corporation shall commence on the date of execution of these articles, if filed with the Florida Secretary of State within 5 days thereafter.

ARTICLE III

Nature of Business

Capital Stock
