In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

### ARTICLE I - NAME AND ADDRESS OF CORPORATION

The name of this corporation is PHYSICAL THERAPY AND REHAB OF DELRAY BEACH, INC.. The street address of the initial principle office of this corporation is South County Professional Center, 16244 South Military Trial, Suite #710, Delray Beach, Florida 33484.
