ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. **NAME.** The name of this corporation Daisy's Ice Cream Parlour, Inc.
2. **ADDRESS.** The initial address of this corporation shall be: 1850 Southeast 52nd Street, Ocala, FL 34480.
3. **TERM.** This corporation shall exist perpetually.
4. **PURPOSE.** The purpose of this corporation is to transact any of all lawful businesses for which corporations may be incorporated under Chapter 607 Florida Statutes.

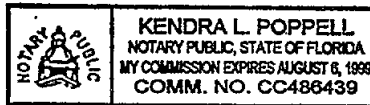
