Enclosed herewith please find the corporate filings for three of my corporations, Canine Counselors, Inc., Canine Counselors of America, Inc. and Good Dog Training, Inc.

The purpose of my letter is to respectfully request a special consideration regarding the lateness of our corporate renewals. On April 9, 1999 my office manager/vice president of twelve years, Julie Hatton, quit without notice which needless to say left my companies in quite a distressful state. With no other alternative I was forced to contract a temporary service, (Girl Friday) and during the following two months had a total of four temporary (fairly incompetent) workers in my office. Finally I have gotten things turned around and one of my original employees from the mid 80's has returned. Recently our accountant called regarding the status of our corporate renewals.
