We have just received the "2<sup>nd</sup> Notice" for the 1998 Corporation Annual Report. We had not received the original notice.

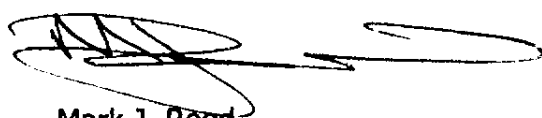
