Please find enclosed our check for \$150.00 and our completed application for reinstatement. The check is for the 1998 annual filing fee.

We incorporated on November 25, 1997 at which time we paid our 1997 annual filing fees. At the time we incorporated, we were located at 501 S. Falkenburg Rd., #E-12; Tampa, FL 33619. We then moved to 9647 Palm River Rd.; Tampa, FL 33619. We didn't realize that we were required to notify the Department of State of our relocation. Also, we were not aware of the requirement to file an annual report and pay the annual filing fee. Apparently the annual report was sent to our former address, and was never forwarded to our present address.
