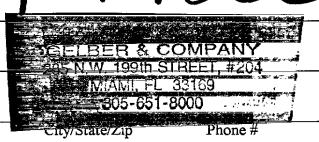

ARTICLES OF INCORPORATION OF

I, PRESTON G. PACKER, do hereby subscribe and acknowledge the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and initial address of this corporation shall be:

The effective date of this corporation shall be JANUARY 1, 1998.

ARTICLE II

The general nature of the business to be transacted by this corporation is any business which is lawful in the United States. The specific nature of this professional association is MEDICAL SERVICES.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property (real or personal), or labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this corporation.

ARTICLE V
