The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereb associate themsel es together for the purpose of forming a corporation by and under the laws of the State of Florida providing for the formation, rights, liabilities, privileges and immunities of a corporation for profit.

# ARTICLE I

The name of this corporation shall be PRIME TRADE CORP.

## ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is any lawful act or activity for which corporations may be organized under the Florida General Corporations Act, or any successor statute.
