ARTICLES OF INCORPORATION

OF

ARTICLE 1

NAME

The name of this Corporation is The Character Laboratory, Inc.

ARTICLE 2

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this Corporation shall be 372 Eron Way, Winter Garden, Florida 34787.

ARTICLE 3
