The undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, providing for formation, liabilities, rights, privileges and immunities of corporation under Florida Statutes, Sec 607.164.

ARTICLE V: This corporation shall commence on January 1, 1998 and exist perpetually.

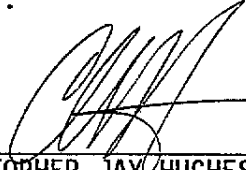

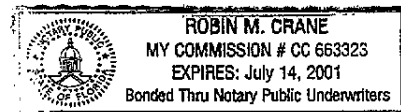
