I Would like to appeal that my corporation MCT Commercial Cleaning, Maintenance & Supply, INC. be reinstated without penalty for the following reasons>_____

1. I know that you office sends out a first notice, that states when the corporation annual report is due. I never received that notice. I have a P. O. BOX number. It must have been put in the wrong box at the post office and you ever received it did not return it to the post office, so they could put it in the correct box.
2. We did receive the second notice. At the time we received the second notice, I was seriously ill. I have been bed ridden for over a month. I had two people who started the corporation with me, but they have been out of the corporation for well over a year. So when I became ill I had to have one of my employees take over running the business. One of the things he was going to do was pick up the mail. All the bills and state and federal forms he was to take to the accountant. For some reason he did not take the second notice to the accountant. When I received the third notice, I started looking for the first & second notices, I found the second notice in between some trade magazines that came in the mail while I was ill.
3. While I have been ill my company has lost over half of the business I had before I became ill and I have used up most of my cash reserves to keep the company running. Right Now I am able to work a couple of hours a day, but I am getting better and hope to be back to work full time in a month. I am trying to hold onto the accounts I have left. Right now I cannot afford \$750.00 reinstatement fee, due to all the things that have taken place since my illness.

For these reasons I ask for your help and hope that you can reinstate my company without a penalty if at all possible.
