The undersigned, acting as incorporator of Vitality Pharmaceuticals Corp., under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Musicom, Inc., and the mailing address of this Corporation is 635 NW 12th Road, Boca Raton, Florida 33486.

ARTICLE II - COMMENCEMENT OF EXISTENCE

This corporation shall commence on the date on which these Articles of Incorporation are filed with the Secretary of State.
