ARTICLES OF INCORPORATION

OF

LEGALNET, INC.

ARTICLES I

The name of this corporation is LegalNet, Inc. of Jacksonville, Florida.

ARTICLES II

This corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

General Purpose and Nature of Business

This corporation is organized for the purpose of transacting and engaging in any and all lawful business or activity permitted under the laws of the United States of America and the laws of the State of Florida, as amended.

ARTICLE IV

Capital Stock

This corporation is authorized to issue one thousand (1000) shares of One Dollar (\$1.00) par value common stock which shall be designated as "common stock."




