## ARTICLES OF INCORPORATION OF SERGIO'S SAUCES, INC.

I, SERGIO APARICIO, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

#### **ARTICLE I**

NAME:

The name of this Corporation shall be: SERGIO'S SAUCES, INC.


#### **ARTICLE II**

#### SPECIAL PROVISIONS

The following additional provisions for the regulation of the business and for the conduct of the affairs of the Corporation and for creating, defining, limiting and regulating the powers of the Corporation, its shareholders and directors, are hereby adopted as a part of these Articles of Incorporation.
