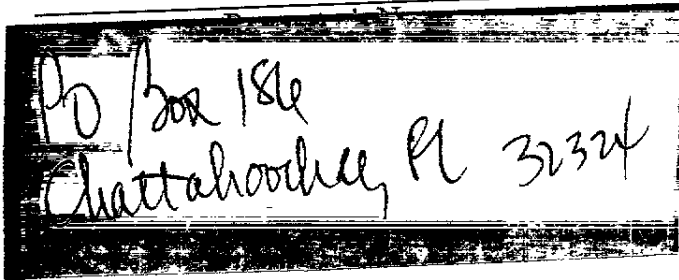

ARTICLES OF INCORPORATION OF THE JONES HOUSE RESTAURANT, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is THE JONES HOUSE RESTAURANT, INC.

ARTICLE TWO

PRINCIPAL OFFICE

ARTICLE THREE

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the restaurant business.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act, or to engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.

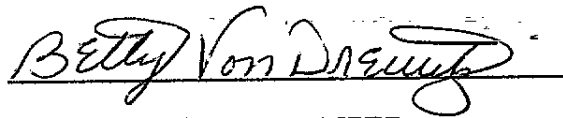

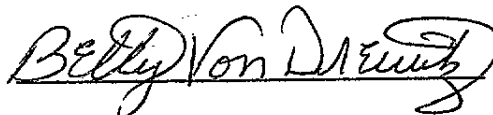
