I have submitted prior correspondence to you regarding the administrative dissolution of the above corporation. The registered agent on my 1999 report, Armando Mizio, listed in block 9, apparently used my barcoded 1999 annual report to file Data Retrieval Services, INC. Annual report. This apparently has caused my corporation information to be filed inaccurately. I am requesting in writing that my corporation be reinstated. I had previously requested that fees paid in 1999 for P97000102615 be applied to my 2000 filing fee for Stacy E. Walker D.C. P.A.

Enclosed is a copy of the 1999 report that my registered agent sent to you with my barcode and Data Retrievals information. As you can see the same registered agent is listed on both our reports, however, I have no affiliation with Data Retrieval Services. I did not discover this error until I logged on to the web site and noticed that the principal place of business was wrong and further investigation revealed that the information was incorrect. The information I was given by the division of corporations regarding the status of the 1999 and 2000 filings over the phone was incorrect as I understand that you rely on what is in the computer. I was told that the corporation was active and filing fees were received for 1999 and 2000. I assumed this information to be correct and it was not until I logged on the website that I discovered the error. This is why I was not aware that administrative dissolution had occurred.

Please make sure that the monies paid to you in 1999 for P97000102615 in the amount of \$150.00 which was cashed be applied to my 2000 filing fee as I had previously requested.
