ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation is L.J. and J.B. Enterprises, Inc. The address of the principal office of this corporation shall be 2638 Miller Court, Weston, Florida 33332 and the mailing address of the corporation shall be the same.

SECOND: The period of its duration is perpetual.

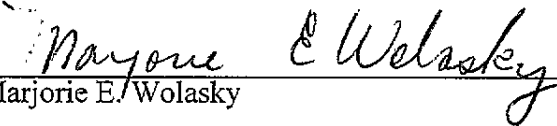

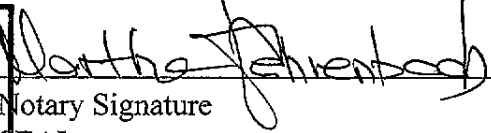

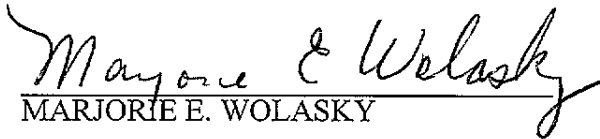
