ARTICLE I - NAME

DIVISION OF SCREEN ATIONS
The name of this corporation is ART & FLORAL GALLERY INCEE, FLORIDA

ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

ARTICLE III - PURPOSE


