# ARTICLES OF INCORPORATION OF PURPLE APPLE SERVICES, INC.

The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

### ARTICLE I. CORPORATE NAME

The name of this corporation is: Purple Apple Services, Inc.

# ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation, which is also the mailing address of the corporation, is 1117 Beach Boulevard, Jacksonville Beach, FL 32250.

#### **ARTICLE III. DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida.
