The undersigned incorporator, for the purpose of forming a corporation under the Horida Business A Corporation Act, hereby adopts the following Articles of Incorporation:

Corporate Name. The name of the corporation is INTERNATIONAL ARTICLE I: NEWSPRINT SUPPLY CORPORATION

Corporate Existence. The corporation shall exist for perpetuity commencing ARTICLE II: as of the execution of these Articles.

Corporate Purpose. The corporation is organized for the purpose of retail and ARTICLE III: wholesale sale of newsprint and paper, and for any and all lawful business allowed under the State of Florida or the United States of America.

Authorized Stock. The corporation is authorized to issue 10,000 shares of ARTICLE IV: common stock, par value \$1.00 each.

Initial Registered Office and Agent. The street address of the initial registered ARTICLE V: officer of the corporation is 3010 South Third Street, Jacksonville Beach, Florida 32250, with a mailing address of the same, and the name of the initial registered agent of this corporation at that address is Lawrence R. Patterson, Esquire.

Principal Place of Business. The principal place of business of this ARTICLE VI: corporation shall be: 232 Pablo Road, Ponte Vedra Beach, Florida 32082.

Power to Amend. The power to adopt, alter, amend or repeal Bylaws shall ARTICLE IX: be vested in the Board of Directors and the shareholders.

Corporate Reservations. The corporation reserves the right to amend or repeal ARTICLE X: any provision contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XI: Preemptive rights. Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time issue bears to the total number of shares by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the price, terms and conditions of the issue of the shares inviting it to exercise its preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
