ARTICLE I - NAME

The name of this corporation is SARAK, INC. The principal office of this corporation is 416 RICHARD ROAD ROCKLEDGE, FL., 32955.

ARTICLE II - DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be JANUARY 1, 1998.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock.
