**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
STAR INVESTORS X, INCORPORATED**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Star Investors X, Incorporated, a Florida corporation, (the "Corporation"), does hereby amend its Articles of Incorporation to change its name as follows:

1. The name of this Corporation is Star Investors X, Incorporated.

2. The amendment adopted is an amendment to Article 1 of the Articles of Incorporation of this Corporation deleting such first Article in its entirety and substituting in its place a new Article 1.

3. The new Article 1 shall read as follows:

FIRST: The name of this corporation is:

Star X Investors, Incorporated

4. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.

5. This amendment to Article 1 of the Articles of Incorporation was adopted by the Incorporator without shareholder approval; shareholder action was not required.
