FIRST: The name of this corporation is:

SECOND: The general nature of the business or businesses to be transacted is to acquire, develop, own, operate and sell commercial real estate or other commercial ventures and to do all and everything necessary and proper for the accomplishment of the objects necessary or incidental to the benefit and protection of the corporation, and to transact any lawful business and to exercise all powers granted to corporations by the laws of the State of Florida.

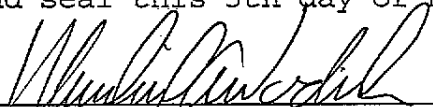

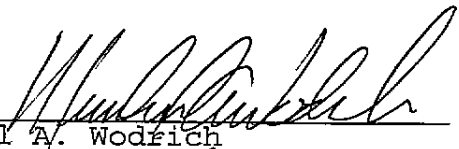
