BYLAWS

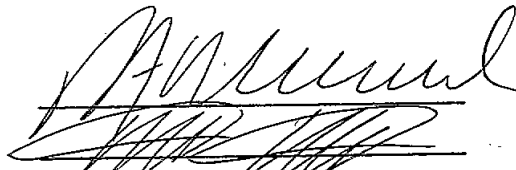

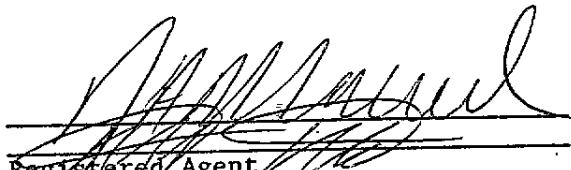
