ARTICLE I

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The Designated Name of the Corporation shall be: Eagle American Trading, Corp.

ARTICLE II

The nature of the business to be transacted by the corporation and its objects and powers shall be as follows:

To engage in any activity or business permitted under the laws of the United States and of the State of Florida, and primarily to engage in the import-export business.
