### ARTICLES OF INCORPORATION OF BILL LIGHT AUTO PLAZA, INC.

ARTICLE 1 - NAME

The name of this corporation is BILL LIGHT AUTO PLAZA, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE
