**ARTICLE I**

**NAME**

The name of the corporation shall be Domestique, Inc.

**ARTICLE II**

**GENERAL NATURE OF BUSINESS**

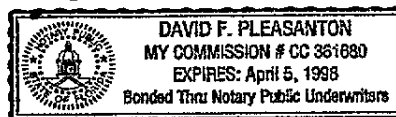
