

ARTICLE IX



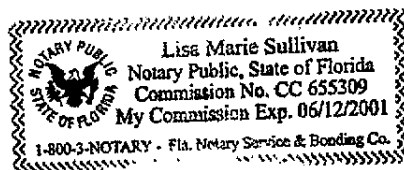


