# Articles of Incorporation of MARILYN A. WAHE, M.D., P.A.

The undersigned incorporator hereby forms a corporation under Chapter 621, Florida Statutes, as follows:

#### Article I-Name

The name of the corporation shall be Marilyn A. Wahe, M.D., P.A., and the principal office and the mailing address of the corporation shall be 201 Eighth Avenue South, Suite 201, Naples, FL 34102.

## Article II-Nature of Business

The corporation is formed for the practice of medicine, and is authorized to engage in such other activities as are permitted under applicable Florida Statutes.
