The undersigned incorporator hereby forms a corporation under Chapter 621, Florida Statutes, as follows:

Article I-Name

The name of the corporation shall be Marilyn A. Wahe, M.D., P.A., and the principal office and the mailing address of the corporation shall be 201 Eighth Avenue South, Suite 201, Naples, FL 34102.

Article II-Nature of Business

The corporation is formed for the practice of medicine, and is authorized to engage in such other activities as are permitted under applicable Florida Statutes.

Article III-Capital Stock

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock with no par value.

Article IV-Registered Agent

The street address of the initial registered office of the corporation shall be 201 Eighth Avenue South, Suite 201, Naples, FL 34102, and the initial registered agent at that address is Marilyn A. Wahe.

Article V-Term of Existence

This corporation shall exist perpetually.

Article VI-Directors

As permitted by Chapter 607.0732, Florida Statutes, there shall be no board of directors of this corporation. All corporate powers shall be exercised by or under the authority of the shareholders, subject to any limitation set forth in these articles of incorporation.
