FOR

*Following Chapter 607 of the Florida Statutes, the undersigned does hereby submit these Articles of Incorporation for forming a profit corporation.*

**Article I - Name and Principal Office**

*The corporation has the authority to issue an aggregate one thousand common shares of capital stock at .01 par value.*


**Article VI - Beginning of Business**

### **Article IX - Powers of the Directors**


*The Board of Directors shall make, alter, or repeal the Bylaws of the corporation without restrictions of their powers conferred by Florida statute.*
