The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is R. W. HOOKER, JR. & ASSOCIATES, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: CORPORATE DURATION

The duration of the corporation is perpetual.

The name and address of the initial registered agent is Robert W. Hooker, Jr., 802 Belle Timbre Avenue, Brandon, Florida 33511.




