# ARTICLES OF INCORPORATION

OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE ONE

The name of the corporation is: ATLANTIS INTERNATIONAL, INC. The principle address of the corporation is: 6346-65 Lantana Rd., Ste. 77, Lake Worth, FL 33463.

#### ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
