The Baobab Farm Corporation was originally set up in December of 1997. I never received an Annual Report for 1998 and I thought that since the initial set up was so late in the year last year that there was no fee this year. At that time I explained the situation to a "yfisher" (on 10/30/98). He advised me that the reason I did not receive the report was because you have the wrong address of record on file. I have since determined that this was as a result of an error made by my registered agent while setting up the Corporation.


I submitted the form (in haste as the credit application was, and is, still pending at the resource where I am trying to set up an account). I made some errors - they have now been corrected. I called to see if I could still be able to pay the original \$150.00 rather than the \$750.00 and the woman said that I should write a letter explaining the situation.

Please consider the situation and advise as soon as possible.

I understand that the errors are ultimately my responsibility, but \$600.00 additional fees seems to be a hefty penalty to pay for a small business trying to get started.

In the event that you decided to require payment of the entire fee please reinstate the status and give me 7 days to pay so that the credit request can go through. The application is with a frost cloth supplier and if we are not able to install the cloth prior to a we may lose the entire crop.
